FINANCIAL BUSINESS

Supplementary Estimates (First Installment) for the year 1969-70.

(i) Supplementary Estimates (First Installment) 1969-70, were presentaioned to the Sabha on the 12th August, 1969, and discussed and voted upon on the 13th August, 1969 (Evening Sitting).

There were 19 demands in all, totaling a sum of Rs. 16340250.

The house decided that all the demands for supplementary grans included in the order paper would be discussed to gether and voted upon separately. All the demand were carried after guillotine. Two members from the Treasury Benches (including the Finance Minister) and three members from the Opposition Benches took part in the discussion speaking for 29 minutes and 53 minutes, respectively.

(ii) The Haryana Appropriation (No. 3) Bill, 1969.

The Haryana Appropriation (No. 3) Bill, 1969 (Bill No. 37-HLA of 1969), in respect of the Supplementary Demands voted by the Sabha on the 1th August, 1969 (Evening sitting), was introduced on the 14th August, 1969 (Morning sitting).

It was before the Sabha for 93 minutes.

Three members each from the Treasury Benches (including the Minister for Irrigation and Power and the Minister for Agricultures) and opposition benches participated in the debate speaking for 27 minutes and 66 minutes, respectively.

LEGISLATION

The Sabha considered Legislative Business on the 12th/14th August 1969 (Morning and Evening Sitting respectively). Eleven Official Bill were introduced, which Appropriation in included one Bill respect Supplementary Estimates (First Installment) for the 1969-70. All them were passed without any amendment except two Bills, namely, the Punjab Legislative Assembly (Allowances of Members) Haryana Amendment Bill, 1969, and the Punjab Urban Immovable Property Tax (Haryana Second Amendment) Bill, 1969.

In addition, the Report of the Select Committee on the Haryana Cattle Fairs Bill, 1969, which was referred to the Select Committee on the 11th February, 1969, was presented to the House on the 14th August, 1969 (Evening sitting. The Bill is at present pending before the Assembly.

SYNOPSIS OF BILLS PASSED BY THE HARYANA VIDHAN SABHA DURING ITS AUGUST SESSION, 1969

1. The Punjab Legislative Assembly (Allowances of Members) Haryana Amendment Bill, 1969 (Introduced on 12th August, 1969 and passed on the 12 August, 1969).

This Bill seeks to amend the Punjab Legislative Assembly (Allowances of Members) Act, 1942, So as-

- (a) to increase the compensatory allowance of the Members of the Legislative Assembly from four hundred rupees to five hundred rupees, per month;
- (b) to increase the halting allowance of the Members of the Legislative Assembly form twenty-five rupees to five hundred, per month;
- (c) to provide telephone facility to the members of the Legislative Assembly at their permanent places of residence or at any other place specified by them. A member provided with a telephone shall be paid fifty rupees per mensem in lieu of calls. The charges in respect of the Calls, whether local, trunk or otherwise made on such telephone in may month exceed fifty rupees, the amount in excess of fifty rupees shall be payable by the Member.
- 2. The Haryana Appropriation (No. 3) Bill, 1969. [Introduced on the 14th August, 1969 (Morning sitting) and passed on the 14 August, 1969 (Morning sitting)].

This Bill seeks to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State of Haryana for the services of

the financial year ending on the thirty-first day of March) 1970.

3. The Punjab Agricultural Produce Markets (Haryana Amendment) Bill, 1969, [Introduced on the 12th August, 1969 and passed on the 14th August, 1969 (Evening sitting)].

This Bills replaces the ordinance which was promulgated to increase the minimum market fee from fifty paise to rupee one on every 100 rupees on the Rabi produce arriving in the Mandis.

4. The East Punjab Agricultural Pests Diseases and Noxious weeds (Haryana Amendment) Bill, 1969 [Introduced on the 14 August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting).

This Bill, while replacing the ordinance, seek to amend the Principal Act, so as the empower the State Government to take immediate measures to eradicate any pest, plant disease or noxious weed from any area, notified under section 3, as it may deem necessary and also to grant subsidy which the State Government may like to give to the occupiers in such area where preventive or remedial measures are carried out for its eradication through aerial operations.

5. The Punjab Urban Immovable Property Tax (Haryana Second Amendment) Bill, 1969 [Introduced on the 14th August, 1969 (Evening sitting and passed on the 14th August, 1969 (Evening sitting)].

This bill, while replacing the ordinance amends the Principal Act so as to levy the surcharge at fifty per centium of the rate of the tax notified under sub-section (1) of section 3 of the Punjab Urban Immovable Property Tax Act, 1940. which was levied in addition to the tax leviable under the said subsection.

6. The Punjab Co-operative Societies (Haryana Amendment) Bill, 1 [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)]

This Bill replace the ordinance which was promulgated to omit section 24(b) of the Principal Act, so that the election of members of Committees of co-operative societies may n future be held in accordance with the oision of section 2(1) other Principal Act and the rules and the rules made there under.

7. The Punjab State Legislature (Prevention of Disqualification) Haryana Second Amendment Bill, 1969. [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)].

This Bill replaces the ordinance which was promulgated to declare that the office of the Chairman of an Improvement Trust constituted under the Punjab Town Improvement Act, 1922, and the office of the Chairman of the State Agricultural Marketing Board constituted under section 3 of the Punjab Agricultural Produce Markets Act, 1961, held by a Member of the Haryana State Legislative Assembly in so far as it is an office of profit under the Government of Haryana

shall no disqualify the holder thereof for being chosen as, or for being, a Member of the Haryana State Legislature.

8. The Haryana Contingency Fund (Amendment) Bill, 1969 [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)].

This Bill seeks to enhance the Contingency Fund of the State of Haryana from seventy-five lakhs rupees to one crore rupees.

9. The Punjab Local Authorities (Aided Schools) Haryana Second Amendment Bill, 196. [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)].

This Bill seeks to empower the Government to continue the management of aided schools for a further period of two year ending with 3the September, 1971.

The East Punjab War Awards (Haryana Second Amendment) Bill 1 [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)].

This Bill seeks not to subject the payment of War Jagirs to deductions on account of suspension or remission of land revenue.

11. The Punjab Public Premises and Land (Eviction and Rent Recovery) Haryana Amendment Bill 1969 [Introduced on the 14th August, 1969 (Evening sitting) and passed on the 14th August, 1969 (Evening sitting)].

With the abolition of the District Boards, it became necessary to replace the words "District Board" by thewods Zila Parishads, Panchayat Samitis; in the Punjab Public Premises and Land (Eviction and Rent Recovery) Act, 1969 to give effect to the provisions of the Act.

NO-CONFIDENCE MOTION AGAINST THE MINSTRY

On the 12th August, 1969, the Speaker held in order all the five notices of motion expressing want of confidence in the Ministry as a whole. The first notice was from Shri Roop Lal Mehta, 2nd and 4th notices were from Dr. Mangal Sein, the 3rd notice was from Sarvshri Birender Singh, Chand Ram, Mukhtiar Singh, S.P. Jaiswal, Balwant Rai Tayal, Banwari Ram and Teja Singh Dardi and the 5th notice was from Shri Shyam Chand. Notice from Shri Roop Lal Mehta being the first in the order of receipt in point of time was put to the vote of the House for leave being granted and as 36 Members rose, the Speaker declared that the leave has been granted and he would allot time for the discussion of this motion later on. Subsequently, on the recommendation of the Business Advisory Committee, The 13thAugust, 1969, was fixed for the discussion on the motion.

On 13th August, 1969 (Morning sitting) Shri Roop Lal Mehta moved the Non-Confidence Motion :-

"That this House expresses its want of confidence in the Chief Minister Haryana and the Ministry as a whole."

and spoke for 25 minutes.

Besides the mover, three Members from the Opposition and three Member from the Treasury Benches spoke for 2hours and 37 minutes and 1 Hour and 13 minutes, respectively.

The Chief Minister by way of reply spoke for 40 minutes Shri Roop Lal Mehta, the mover of the motion spoke for 8 minutes, by way of reply.

The motion was then put to the vote of the House and was declared lost by 42 (noes) to 36 (Ayes).

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969 (EVENING SITTING)REGARDING ADMISSIBILITY OF CENSURE MOTION AND DISCUSSION THEREON

I think, we have now discussed this matter a great deal. The issue is being made so complicated that I am even hesitant to give a ruling today. But since we have already gone thought this affair for a length of time, I think I would be wasting a lot of time of this House if I reserve my ruling for another day. To my mind, I should normally go by very simple rules and code of behavior. The thing is that the House is the master of itself. It can decide whatever it likes. Its action cannot be questioned anywhere. Of course, we cannot do anything against the Constitution, but the fact remains that the House is the master of itself. I can only say that the motion of the adoption of the business for today was moved by our Finance Minister Sahiba and was approved by the Hose, which contained 'Censure Motion' as the last item. So, I am afraid, the House has already taken a decision in regard to the Censure Motion, and it will be taken up today.

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969
(EVENING SITTING)REGARDING DISCLOSURE OF IDENTITY
OF A PERSON WHOSE NAME BE REFERRED TO BY A

MEMBER IN CONNECTION WITH TAPE RECORDED TALK OF CH. KHURSHED AHMED

I hope the hon. Members have heard everything. I would now give my ruling on this subject. The conduct of an hon. Minister is involved. We are being told that tow persons are talking. One is the hon. Minister himself. The other name given is Dharam Pal, but his identity has not been disclosed. I cannot, therefore, allow this evidence to be read any further. In fact, an objection to this should have been raised in the very beginning.

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969 (EVENING SITTING)REGARDING THE PLAYING OF TAPE RECORDER IN THE HOUSE

A very important point has been raised by the hon. Minister. I knew that you had asked about this tape record to be played and I myself had gone to Delhi a few days ago to discuss with the authorities concerned about this matter. We have got references in writing even from Bombay Legislative Assembly, form the Lok Sabha and from the Institute of Constitutional and Parliamentary Studies and so on. Now they say if you want the whole thing to be brought in that the tape cannot be played here. But we can appoint a committee perhaps headed by the hon. Deputy Speaker, one Member from the Treasury Benches and one Member from the Opposition

Benches and we can take a gist or complete verbatim talk prepared. Then both the tape and the thing prepared by the committee becomes the property of the House. But unless either the tape is allowed to be payed here, and at one time it was about to be agreed or this committee takes that evidence, the tape cannot become the property of the House.

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969 (EVENING SITTING)REGARDING IN RESPECT OF THE GOVERNOR IN A SPEEH BY AN HON. MEMBER

All that has been said about the Governor, will be removed from the proceeding. In fact, it will be in the fitness of things that no reference is made to the Governor. Anyhow, whatever has been said about the Governor and the coversaiton, must not form part of the proceedings.

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969
(EVENING SITTING) REGARDING DISCOUSING THE NAME OF
AN OFFICER BY CH. RANIBRI SINGH BY DRAWING
INFERENCE FROM THE TAPE RECORDED DIALOGUE

Well the point is if he does not give reasons, for exaple, earleir on Ch. Ranbir Sing had given in his inference after a certain dialouge, then you really cannot object because it is reasonable assumption; because of the coversation. If this conversation is not correct then naturally you can't sya he was there. But if we accept what Mahant Ganga Sagar ji has said is correct, then the inference is not wrong.

RULLING GIVEN BY THE SPEAKER ON 14THE AUGUST, 1969
(EVENING SITTING)REGARDING INSINUATION AGAINST AN
HON. MEMBER.

As per rules, no isinuation can be brought against him at the moment unless there is a Privilege motion against him. So unless there is a Privilege or substantive motion against him. So, unless there is a Privilege or substantive motion against him, no insinuation, as per Rule 100(vi) can be made agaisnt him.

(EVENING SITTING) REGARDING ADMISSBILITY OF
AMENDEMENT FOR WHICH NOTICE FOR TOW DAYS WAS NOT
GIVEN WHICH WAS ESSENTIAL TO CARRY OUT OBJECTS OF
THE BILL AS REQUIRED UNDER EXPLANATION i OF FULE 158

Let us review the whole thing. What had happend was that a Member had introduced an amendement while we were considering this Bill clause by clause and he had not given tow days notice. That was accepted and made per of the Bill. The same member, after a while, brins antohter amendement and that earlier on he gave a notice of one hyour I don't know what the exact period was, but less than two days. In this case written notice of 20 or 15 minutes was given

and that got challenged. So when we have accepted his earlier amendemtn? If your remember, Rao Sahib had raised only one point and, that was: he did not give notice of that amendment. Then I was informed by my Secretary that the notice in case of this amendment also had been received 15 or 20 minutes beofer. Therefore, there was no option for me but to accept the second amendment. I gave my ruling and the then every body appeared to be satisfied. But now other issues are being raised. I ahve given any ruling and I don't think that nay member should now raise discussion on it any further.

POINTOF ORDER AND DECISION THEREON

1. Wheter motion of No-Confidence should be taken up after the question hour under rule 65 of the Rules of Precedure and Conduct bo Busness?

The hon. Speaker observed that ho. Members would recall that las time which such situation had arisen then no other business was taken up except for obituary references. Therefire, it was proper if the House had taken up except for obituary references. Therefore, it was proper if the House had taken upt the motion of No-Confidence on the next day. (This point of order was raised by Shri Mangar Sein on 11th August, 1969 when obituary references were being made).

2. Whether an amendement can be moved of which no totice has been given and which has also not been cirulated?

The Spekar observed, that as far as the amendment was concerned, it was in order under rule 158 (1) Explanation 3 which reads as under:

"Nothing in theis clause shall be construed as preventing any Minster or member in-charge of a Bill from moving an amendment at any time during the consideration of the Bill clause by clause."

[The above point of order raised by Dr. Managal Sein when Shri Daya Kriswhan moved his amendment in regard to Punjab Legislative Assmebly (allowances of members) Haryan amendment Bill]. 3. Whether the speker can pre-pone the sitting after he has adjourned the House till 2.00 P.M. ?

The Speaker observed that he had got unquestionalbe authority in such matters (This point of order was raised by Shjri S.P. Jaiswal on 13th August, 1969).

4. Whether the time of the sitting of the House could be preponed by the Speker keeping in view the interest of the Minstry or it could be done only in the public interest?

The Speaker observed that there was no doubt that there were too vast powers with him in the Rule – "Unless the Speaker otherwise directs" and the hon. members were not averse to the tow sittings therefore, it was left to him as to what course should be adopted. (On 13th August, 1969 Chj. Mukhtiar Singh and Roa Birender Singh raise dthis point of order).

5. Whether any hon. Member could give infformation through a question instead of eliciting information?

The Speaker observed that question were asked to elecit information but, if by chance some point was not clear the questioner could get it ampliefied or cleared by giving some information just to get the anser he wanted. So, he did not think, that proper to be rigid on that matter. The hon. Member was saying all this with a view to elicit more inform ation. (On 14th August 1969 Ch. Ranibir Singh raised this point of order).

6. Whether a Member can refer to a Member by name?

The Speaker observed that the hon, members of one side has been makeing references to individuals off and on. Although, he agreed that constant reference should not be made to an ho, member yet if there was occasional reference to the nature of Member then it could be done. (On the 14th August 1969 Ch. Chand Ram raised this point of order).

7. Whether it is necessary or not for a member who has quoted tape recorded talk between tow persons, to disclose the indentity of those perosn?

The Speaker observed that he entirely agreed that the House must be assured who that other gentleman Dharam Pal was? Unelss he told them they would not be able to decide whether he was a Government Servant or otherwise. So he thought that was only fair. After all that Dharam Pal was talking to a Minister, a public man and there politics was also involved. If he was a Government Servant he would not be able to defend himself in the House. The House could only go further if it was told who that Dharam Pal was? (On 14th August, 1969 the Chief Minister raised theis point of order).

8. Whether or not the tape recorder once played in the House became the property of the House?

The Speaker observed that he agreed that if the tape recorder was used there—that would certainly become the property of the House. But you will agree that if he allwoed that if he allowed that, it would become a precedent. The opposition asked for a permission ot pay the tape recorder in the House. But he was afraid that that could not be given

under the rules. (On 14th August, 1969 the Finance Minister raised this point of order).

9. Whether or not the matter which is read from the tape record could be treated as property of the House?

The Speaker observed that the document that the hon. Member reading had in his hand and up to the stage it had been read by him had become the property of the House. (On 14th August, 1969 the Finance Minister raised this point of order.)

10. Whether a member could be forced to give information beyond which he did not like to give?

The Spekaer observed that so far as he had been able to find out, he could not force a member to give certain information. He further observed that if somebody could find out the Rule, he was open to coviction. (On 14th August, 1969 Rao Birender Singh raised this point of order.)

11. Whether a question can be asked from an hon. member by some other member when one of them was making a speech.

The Speaker observed that it appears a question had been asked about some other hon. Minister, I think, it was unfair that some body asked a question. I could not hear it. But the name was given. So that will be expunged from the proceedings. (On 14th August, 1969 Shri Poswal raised this point of order.)

12. Whether the matter published in news papers and posters could b discussed in the House?

The Speaker observed that whatever applied to the news itmes, also applied to the posters. (On 14th August, 1969 Shrimati Chandravati raised this point of order

13. Wehter the names of outsiders coiuld be mentioned in the speeches?

The Speaker obsderved that normally no outsider could be quoted. But if private persons in whose respect a member took responsibility about facts, they could be mentione tehre (On 14the August, 1969 Chief Minister raised this point of order).

XI. Point of Order

Shri Ram Saran Chand Mital, M.L.A. stading on point of Order objected to the allowing of Censure Motion given notice of by Shri Ganga Sagar Mahant, M.L.A., against Shri Khurshed Ahmed, Minster for Health on the founds –

- 1. There was no provisions in the Rules of Procedure and Conduct of Business in the Assmebly for allowing a Censure Motion agaisnt an individual Minister.
- 2. Rule 65 of the Rules of precedure and Conduct of Business in the Assembly provides for a No-Confidence Motion against the Ministry as a whole or against a Minister for disapproveing the policy of a Minister or the Minstry as a whole;
- 3. The Censure Motion was a sort of No-Confidence Motion agaisnt a particular Minister which under the Tules could not be permitted as every action of a Minister was the joint responsibility of the whole Minstry and a No-Confidence Motion agaisnt the Minstry as a whole had already been discussed and rejected by the House only a day earlier;
- 4. That when the No-Confidence Motion has been decided by the House earlier, a No-Confidence Motion or a Censure Motion against a Minister is not admissible in the same Session under rule 81 of the Rules of Procedure and Conduct of Business in the Assembly being identiacal motion on which the Assembly has given verdict;
- 5. No motion can be allowed in the Rules to censure the conduct of a Minister or a Member.

The Point of Order was ruled out of order by the Speaker saying that the siad motion had already been admitted by the House when the Third Report of the Business Advisory Committe was adopted by the House.

XII. Censure Motion

Shri Ganga Sagar Mahant moved -

"That this House hereby censure the Minister of Health, Shri Kurshed Ahmed for his undemocratic, vindictive and arbitary administration of local bodies and Health Depairtment particulary for his conduct which is unbecoming of a Minister and a Legislator".
